KACC TO ARRAIGN IN COURT FORMER NAIROBI MAYOR AND WIFE TO FORMER MINISTER TO ANSWER CORRUPTION RELATED CHARGES.

Dear News Editors,

The Kenya Anti-Corruption Commission (KACC) kindly requests you to publicize and inform the general public of the following.

The Kenya Anti-Corruption Commission will this afternoon **13th July 2010 at 2:00pm** arraign before the **Nairobi Anti-Corruption courts** former Nairobi **Mayor John Ndirangu Kariuki, Eustus Mwangi Mungai and Isabel Vickly Nzalambi** (wife of former Minister Hon. Katana Ngala). The Kenya Anti-Corruption Commission hopes to get summons to arrest and arraign in court former Minister Hon. Katana Ngala, Hashim Got Sat; and Elizabeth Nyambura Gicheha.

They will be charged with conspiracy to defraud contrary to section 317 of the Penal Code, against all the six suspects; Stealing by a person's employed in the public service contrary to section 280 of the Penal Code against John Kariuki Ndirangu, the former Mayor of Nairobi and Hon. Katana Ngala, the former Minister for Lands; Uttering a false document contrary to section 353 of the Penal Code and handling stolen property contrary to section 322(2) of Penal Code, against Hon. Katana Ngala; Perjury contrary to section 108 as read with section 110 of the Penal Code against Isabella Vickly Nzalambi.

KACC commenced investigation into allegations that the residence reserved for the Mayor of Nairobi had been unlawfully and fraudulently acquired. Upon completion of the investigations, the Commission ascertained that, indeed the said mayor's residence was fraudulently transferred to the wife of Hon. Katana Ngala.

Subsequent to the completion of the investigations, the Commission forwarded a Report of its findings to the Honorable Attorney General recommending the prosecution of several suspects involved in the fraudulent transfer, and recovery of the said property. The AG concurred with our recommendation and directed that they be arrested and arraigned before court to face various charges

Kindly publicize and broadcast this information to the public in your respective media.
The fight against corruption continues.
