PRESS RELEASE – KENYA ANTI-CORRUPTION COMMISSION GETS PRESERVATION ORDERS FOR PROPERTIES WORTH QUARTER OF A BILLION SHILLINGS.

3rd May 2007

The Kenya Anti-Corruption Commission has been issued with ten (10) preservation orders from a High Court in Mombasa in respect to 29 properties located in prime areas on Tudor Road (now Tom Mboya Avenue) in Mombasa and the Kenya Airport Authority land in Malindi, Mombasa and Ukunda Airstrip all valued at a quarter of a billion shillings. The applications by KACC are under Section 56 of the Anti-Corruption and Economic Crimes Act No. 3 of 2003 to prohibit the transfer or disposal of or other dealings (Howsoever described).

The 10 orders issued on 25th April 2007 by Hon. Mr. Justice L. Njagi prohibit:

The Commission has been conducting investigations on illegal and irregularly acquired properties in prime land areas near Nyali creek and around major airports in Coast Province for the past couple of months. The Kenya Anti-Corruption Commission is in the process of registering the prohibitions on the property files in due course.

The Commission acknowledges your contribution towards the fight against corruption and calls upon you to give this press release coverage as much as possible.
