
During the month of October 2011, the Reports Centre (Nairobi, Mombasa & Kisumu) processed a total of 515 reports.



## **4.2 Monthly Activities**

#### Mombasa

- 1. Intelligence activities and surveillance at the Mariakani weighbridge.
- 2. Surveillance on corrupt activities at Kilindini Port and tax evasion at the border entry point of Taveta with a view of conducting a sting operation. Investigations are ongoing.

- 3. Intelligence probe on a consignment of condemned sugar lying at the Customs warehouse Kilindini whose destruction has been put on hold due to vested interests by senior KRA officers. Investigations are ongoing.
- 4. Completed Preliminary Investigations into allegations of tax evasion during the transfer of Plot No. 3966/MN/1 (Nyali).
- 5. Joint forensic investigations into allegations of collusion by lands officers and other parties to fraudulently acquire a 25 acre beach plot in Kwale i.e. Block 151/Kwale Diani Beach plots.
