IMPERSONATORS AS KACC OFFICERS ARRESTED.

Dear News Editors,

The Kenya Anti-Corruption Commission (KACC) kindly requests you to publicize and inform the general public of the following.

The Kenya Anti-Corruption Commission arrested **HARRISON KINYANJUI 'alias Andrew Sang'**, **PAUL OMUSULA MUNYALE 'alias Amos Liboi'** and **JACOB KIPNYANGO MAIYO** who have been impersonating KACC Investigating Officers. These fraudsters are enriching themselves by extorting money through harassment and solicitation from unsuspecting individuals purporting that they can assist in stopping investigations and/or prosecution of corruption cases.

The three men were arrested on Thursday 1st July 2010 in Westlands area soliciting for a bribe of Ksh. 4million from, Mr. Mohammed Rao – the Chairman of Islam Foundation of Kenya. They had claimed to be investigators from the Kenya Anti-Corruption Commission and they were investigating the sale of a property of the foundation situated along Mfangano Street, Nairobi, which they claimed had an outstanding land rates amounting to Kshs. 7.84 million. The bribe was so as to give a favourable report in the alleged case they were investigating.

Mr. Rao contacted Investigators at Integrity Centre where a Rapid Response Operation was conducted by officers from Kenya Anti-Corruption Commission. Two suspects Paul Omusula Munyale 'alias Amos Liboi' and Jacob Kipnyango Maiyo purporting to be immigration officer based at Kisumu were immediately arrested. The third accomplice, Harrison Kinyanjui 'alias Andrew Sang' was subsequently arrested.

Following the arrest, fake identification cards purporting to have been issued by KACC were recovered including various documents with KACC letter head, a Police Certificate of Appointment card, investigating officer cards purporting to be from NHIF, City Council of Nairobi, Kenya Revenue Authority, Immigration Department, Practical Action – Eastern Africa and other documentations including fresh applications for registration as a citizen of Kenya. The Commission is investigating further to authenticate the true identity of the persons arrested and the cards they were holding including the documents at hand.

The suspects will be arraigned in court immediately investigations are complete.

Members of the public are therefore cautioned to be on the look out for such individuals and to report them immediately to the Police or the Kenya Anti-Corruption Commission.

Kindly publicize and broadcast this information to the public in your respective media. The fight against corruption continues.
