During the month of **November 2011**, the Reports Centre (Nairobi, Mombasa, Nyeri & Kisumu) processed a total of 664 reports.


- 567 reports processed in Nairobi.

Categorization of reports processed by EACC in October 2011 (awaiting data from Eldoret and Garissa)





4.2 Monthly Activities

Mombasa

- 1. Intelligence activities and surveillance of SGS staff and police officers manning the Mariakani weighbridge.
- 2. Surveillance on corrupt activities at Kilindini Port and tax evasion at the border entry point of Taveta with a view of conducting a sting operation. Investigations are ongoing.
- 3. Intelligence probe on allegations of irregular tendering at the Kenya Bureau of Standards. Investigations are ongoing.
- 4. Joint forensic investigations into allegations of collusion by lands officers and other parties to fraudulently acquire a 25-acre beach plot in Kwale i.e. Block 151/Kwale Diani Beach plots.
