
## **REPORTS CENTRE**

The following table highlights disposal of the reports.





#### Mombasa

- 1. Intelligence probe on corrupt activities and tax evasion at Kilindini Port. Investigations are ongoing on alleged diversion of transit (export) goods into the local market by unscrupulous businessmen in collusion with KRA officers.
- 2. Monitoring the destruction of condemned sugar as per Court Order issued to Mumias Sugar Company Limited, the plaintiff in the Civil suit no. 251 of 2007.

#### Kisumu

Intelligence activities within Kisumu into alleged sale of Government drugs at some Chemists. The matter is on-going to ascertain the allegations.
